1. Online Services Account

Dear parents and carers,

Our school provides access to Department of Education online services. These enhance the learning opportunities available to students and the range of teaching tools available for teachers to deliver the Western Australian Curriculum.

I am writing to seek approval for your child to be given access to these online services. The Department's online services currently provide students with access to:

- individual email and calendar accounts
- the internet, with all reasonable care taken by central office and schools to monitor and control students' access to websites while at school
- online teaching and learning services such as Connect and digital resources
- online file storage and sharing services
- these online services at locations other than school

Please note that while every reasonable effort is made by schools and the Department to prevent student exposure to inappropriate online content when using Department provided online services, it is not possible to completely eliminate the risk of such exposure.

You should be aware that the Department has the right to review, audit, intercept, access and disclose messages created, received or sent over Department online services. Logs of email transactions and internet access data are kept for administrative, legal and security purposes and may be monitored. Similar to other corporate records, emails and internet access records are discoverable in the event of legal action and are subject to provisions of the Freedom of Information Act 1992. (www.foi.wa.gov.au)

You should also be aware that general internet browsing not conducted via the Department's network is not monitored or filtered by the Department. The Department encourages close family supervision of all internet use by children in locations other than school, and strongly recommends the use of appropriate internet filtering software. Advice on managing internet use at home can found on the Office of the E-Safety Commissioner website (www.esafety.gov.au/iparent).

2. Acceptable Use Agreement

The following rules set out the expectations and code of conduct for all students using an online services account and obtaining access to computers and the related internet services at school.

If you use the online services of the Department of Education you must agree to the following rules:

- Use the school computer only with the permission of a teacher.
- Follow all instructions from teachers when using school computers.
- Keep passwords safe and private.
- Only use my own online services account.
- I am responsible for anything that happens when my online services account is used.
- Notify my teacher if I think someone is using my online services account.
- The Department of Education may see anything I send or receive using the email service.
- I will make sure that any email that I send or any work that I wish to have published is polite, carefully written and well presented.
- Use material and information from Internet sites or other sources only if I have permission to do so and I acknowledge the source of information.
- If I see any information or images on the computer that makes me feel uncomfortable, I will tell my teacher straight away.
- Do not reveal personal information, including names, addresses, photographs, credit card details and telephone numbers of myself or others.
- I will not damage or disable the computers, computer systems or computer networks of the school, the Department of Education or any other organisation.

I understand that:

- I will be held responsible for my actions while using online services and for any breaches caused by allowing any other person to use my online services account.
- The misuse of online services may result in the withdrawal of access to services and other consequences dictated in Schools policy; and
- I may be held legally liable for offences committed using online services.

If you agree to abide by the acceptable use agreement for school students, you must complete and sign section 2 of the agreement on the back page.

I understand that if I am given an online service account and break any of the rules in the agreement, it may result in disciplinary action, determined by the principal in accordance with the Department's Behaviour Management in Schools policy.

3. Student Mobile Phones in Public Schools

Policy

The Department of Education does not permit student use of mobile phones in public schools unless for medical or teacher directed educational purpose.

For the purposes of this policy, 'mobile phones' includes smart watches, other electronic communication devices, and associated listening accessories, such as, but not limited to, headphones and ear buds.

Morley Primary School recognises that an increasing number of parents/carers who for safety, security and/or emergency purposes wish to provide their children with mobile phones. This policy details the conditions under which mobile phones at permitted at Morley Primary School.

Conditions of Use

The use of mobile phones for all students will be banned from the time they arrive at school to the conclusion of the school day. This includes before school and break times.

Mobiles phones brought to school by students, must be switched off and taken to the administration office before the school day begins. They should be signed in each day via the register at administration, where they will be in safe keeping. Students will then need to report to the office and sign their phone out at the end of the day.

Exemptions

Students from Kindergarten to Year 6 are not permitted to have mobile phones in their possession during the school day; unless the student has been granted an exemption, to monitor a health condition as part of a school approved documented health care plan. Exemptions can only be approved by the Principal.

Breaches of this policy

Breaches of this policy will be managed in line with the Morley Primary School Mobile Phone Policy.

4. Media Consent

Children's images and/or their work may be published to recognise excellence or effort. They may appear in electronic newsletters attached to the school website, or in film or video. Their first names and year level may be included but no contact details are provided. Work/images captured by the school will be kept for no longer than is necessary for the purposes outlined above and will be stored and disposed of securely.

5. Third Party Services

Morley Primary School uses a number of applications and online platforms to support student learning. Some of these resources are provided by the Department of Education and some come from Third Party Services. The purpose of these applications are to assist in the implementation of the curriculum, and to support student achievement and progress.

These providers may store personal information, including name, date of birth and records of student achievement. Many services use student achievement data to individualise feedback and to differentiate student learning.

A Third Party risk assessment has been undertaken by the Department for each application and a catalogue is available to all schools. Those applications deemed to pose a high risk will not be used.

The following third party services are being used in our school, and some require individual consent for each service. Please read the following attachment and indicate your consent where appropriate. Please contact the school should you have any questions.
